## SPECIAL EVENT Tent & Propane Permit

**TENT PERMITS – Fire Department inspectors will enforce fire regulations.**

1. Tent permit and "Certificate of Flame Resistance" must be displayed in tent at the special event
2. It is the Vendor's responsibility to ensure each tent is flame resistant and to provide a "Certificate of Flame Resistance" "Contact retailer where tent was purchased of rental agent for the "Certificate of Flame Resistance".
3. Each tent requires a minimum 10:B:C fire extinguisher

**4. NO STAKES ALLOWED IN ROADWAY**

**NOTE: A DETAILED SITE & FLOOR PLAN** is required for tents, canopies, and membrane structures with an occupant load of 50 or more floor plan must indicate details of the means of egress and type of heating and electrical equipment.

**PROPANE "LPG" PERMIT- Fire Department Inspectors will enforce fire regulations.**

1. LPG Propane Permit must be displayed at each vendor location.
2. Propane tanks are to be secured in an upright position and not subject to physical damage.
3. Each propane location requires a minimum 10:B:C fire extinguisher.
